I understand that the following restrictions apply:

1. Weeks are reserved on a first-come, first-served basis and begin either on a Saturday or Sunday. All requests must be submitted in writing.
2. You must choose either to use the week at the resort or within an exchange system. You must submit three choices if you plan on staying at the resort and the week cannot be reserved more than 365 days in advance.
3. You may not carry your weeks over from one year to the next within the Harbor Ridge Flexible Use Reservation system, unless you pay an internal exchange fee of \$149.
4. You may deposit your 2025 week with an exchange company and travel to another resort location. Your **Interval International membership must be valid until December 31, 2025.**
5. You may not reserve a week at Harbor Ridge until all assessment fees and any other outstanding charges are paid to the Association. If you do not choose to use your week at Harbor Ridge or with an exchange company, you are still responsible for all assessment fees.
6. **To guarantee a regular deposit, your week must be requested by February 1, 2025.**
7. If you do not decide in a timely fashion regarding your week, you may be obliged to take the remaining inventory that may not fit your request or schedule.
8. If you decide to change a confirmed reservation at Harbor Ridge, there is an additional \$25.00 processing fee.
